Regarding provisional affiliation for increase in intake in B. Tech. in Mechanical Engineering from 60 to 120 seats for the session 2011-12.

Reference to the subject noted above, It is intimated that the inspection committee. constituted by this University to check the availability of requisite infrastructural facilities, faculty, labs and other support systems, visited the P.M. College of Engineering, Village Kami, Sonepal on dated 04-8-11 and vide its report dated 04-8-11 (copy already made available to your institute) did not recommend the proposal for increase in intake in B. Tech. in Mechanical Engineering from 60 to 120 seats for the session 2011-12, unless the college developed the necessary infrastructure and faculty which the college lacked then.

On your request vide reference No. PMCE/11/474 dated 18-11-11, regarding reconsidering the matter for provisional affiliation for increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12, another committee was constituted on 04-01-12 to cause a re-inspection of the college. This committee visited the college on 06-02-12. Vide its report dated 02-3-12 (copy attached), this committee too did not recommend the proposal for increase in intake in B. Tech. in Mechanical Engineering from existing 60 seats to 120 seats for the cademic session 2011-12 as the college failed to recruit the requisite eligible faculty members as per AICTE / University norms,

The Vice-Chancellor, after considering the reports of both the inspection committees. has not granted the provisional affiliation for increase in intake in B. Tech. in Mechanical Engineering from existing 60 seats to 120 seats for/from the session 2011-12.

Inspection Committee comprising Prof. R.K. Garg (Convener), Dr. Victor Gambhir, Dr. A.K. Berwal and Dr. Pawan Dahiya was constituted vide office No. DCRUST/CB/707 dated 02-12-2011 to check the compliance report and to verify the availability of requisite Infrastructural facilities, faculty lab and other support system in order to consider the matter regarding to grant provisional affiliation for increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12. The Committee visited the Institute on 06-02-2012.

## **OBSERVATIONS & RECOMMENDATIONS**

The observations of the committee based on physical verification of the infrastructural facilities for the above said proposal are as under:

The availability and condition of the Infrastructural facilities, Laboratories and other support system are more or less same as reported by earlier committee, in its report dated 04-8-2011, constituted under the convenership of Dr. K. D. Gupta, Professor in Mechanical Engineering of this University

The present intake of the college is 360 (60 each in ME, CE, CSE and 120 in ECE) the College needs increase intake in ME from 60 to 120. As per the scheme of studies and examination for the 1<sup>st</sup> year of its degree programme applicable in this college and DCRUST, atleast Seven Faculty memory of Mechanical Engineering are required, exclusively to teach the subjects related to Mechanical Engineering to the students of 1<sup>st</sup> year i.e. common to all branches. The college in addition is running Mechanical Engineering Branch for the session 2009-10, 2010-11 and 2011-12 with an intake of 60 each year. For 2<sup>nd</sup> and 3<sup>rd</sup> year of Mechanical Engineering, 120 students, atleast eight faculty members of Mechanical Engineering are required (as per Teacher student ratio of AICTE). Thus the total Faculty strength in Mechanical Engineering should be 15.

The college had claimed 12 faculty members on roll as on 06-02-2012 including Dr. M.K. Jain who is otherwise working as Director / Principal of the College. Only 09 Faculty members were present in the college during inspection and two faculty members were claimed on leave. As per records there is not even a single approved Faculty member and only TWO Faculty members may be eligible for teaching post in Mechanical Engineering as per AICTE / University norms. Which possess Master Deglee in Mechanical Engineering as claimed by the College. Out of the total strength of Faculty members available in the college, nine faculty members had joined in the month of November, 2011 or later. The faculty retention is very poor.

The college failed to recruit the requisite eligible faculty members and in view of acute shortage of eligible faculty members, we recommend not to consider the matter regarding increase of intake in Mechanical Engineering from 60 to 120. University may inform AICTE about the status of the College so that they may reconsider increase in intake.
