

Subject: Inspection Report of P.M. College of Engg., Kami (Sonepat) on the basis of the shortcomings pointed out by the previous committee and the reply tendered by the Institutions thereof.

A committee consisting of the following visited P.M. College of Engg., Kami (Sonepat) on 27.09.2012:

- 1. Dr. S. K. Garg, Professor, Deptt. of Mathematics Convener
- 2. Sh. Dinesh Singh, Asst. Professor, Deptt. of CSE
- 3. Sh. Anand Chauhan, Asst. Professor, Deptt. of Mgt. Studies Member

The observations of the committee are as follows:

- 1. Though the institution claimed that 06 (six) students have been admitted in each of the two courses i.e. BBA and BCA, yet the faculty members informed that actually 01(one) student in each course is on rolls.
- 2. As per observations of the committee, the approach to the campus is very difficult especially for the girl students.
- 3. A big computer lab is under construction and it may take another six months for the completion.
- 4. The college Branch may check the need for FDR and the Affiliation fee as and when required.
- 5. 150 Nos. computers have been purchased by the institution but are yet to be installed in the labs.
- 6. The post of Director has been filled with a person of sufficient qualification and experience, but he will the age of 65 in December 2012.
- 7. The requisite faculty for the start of these two courses was in place. It was felt that the constitution of the one of the selection committees is not proper and the panel suggested by the experts is not strictly followed. The emoluments of the faculty members are also not as per the grades mentioned in the appointment letters.
- 8. The numbers of books were sufficient keeping in view the actual enrollment.
- 9. One of the class rooms had not sufficient furniture for intake of 60 students.
- 10. The faculty rooms were neither proper nor properly furnished.
- 11. The committee did not felt the need to inspect the mess, hostel and canteen separately keeping in view the status of admission.
