Subject: Regarding continuation / extension of provisional affiliation of existing courses with earlier sanctioned intake for the session 2014-15.

It is intimated that the inspection committee, constituted by this University, visited your institute on 13.08.2014 to check the availability of requisite infrastructural facilities, labs, faculty and other support systems, etc. (a) to consider the matter of continuation / extension in provisional affiliation in respect of existing courses, i.e., B. Tech. in CE (60 seats), CSE (60 seats), ECE (120 seats), ME (120 seats), EE (60 seats), Aeronautical Engg. (60 seats), Automobile Engg. (60 seats), BBA (60 seats), BCA (60 seats) and M. Tech. in CSE (24 seats), M. Tech. in ECE (24 seats) and M. Tech. in ME (30 seats) (b) to consider the start of new additional PG course in M. Tech. in Civil Engg. with an annual intake of 30 seats and (c) to consider increase in intake in B. Tech. in Aeronautical Engg. from 60 seats to 120 seats from the session 2014-15 and has submitted the report.

The Vice-Chancellor, after considering the report, has been pleased to grant provisional affiliation for the session 2014-15 for the existing UG & PG courses with earlier sanctioned intake, i.e., B. Tech. in CE (60 seats), CSE (60 seats), ECE (120 seats), ME (120 seats), EE (60 seats), Aeronautical Engg. (60 seats), Automobile Engg. (60 seats), BBA (60 seats), BCA (60 seats) and M. Tech. in CSE (24 seats), M. Tech. in ECE (24 seats) and M. Tech. in ME (30 seats). **New PG course in Civil Engg. and increase in intake from 60 to 120 in B. Tech. Aeronautical Engineering for the session 2014-15 are not recommended as adequate qualified faculty is not available subject to the fulfillment of the deficiencies pointed out by the inspection committee. The photocopy of the inspection report dated 13.08.14 is enclosed herewith for necessary**

compliance (alongwith all supporting documents / proofs such as bills of materials / items procured, photographs / maps of facilities created etc.). The compliance report be submitted within one month.

The above provisional affiliation for the existing UG/PG courses with earlier sanctioned intake is further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time.

Further, it is made clear that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.
